THE PROGRAM IS DEVELOPED IN 6 GEOGRAPHIC AREAS IN ETHIOPIA: BOLE BULBULA AND MESERET KRISTOS PROJECT AREAS NEAR THE CAPITAL CITY OF ADDIS ABABA; SHASHEMENE, HANICHA AND GUTUMUMA PROJECT AREAS IN THE SOUTHERN REGION; AND THE DEMBIDOLLO PROJECT AREA IN THE WESTERN REGION. THE PROJECT AREA WAS ALSO SELECTED DUE TO EXTREME POVERTY CONDITIONS, THE NEED FOR INTERVENTION AND GOOD OPPORTUNITY FOR SMALL BUSINESS SUCCESS FOR THE FAMILIES IN OUR PROGRAM.
